The Mayor called the meeting to order at 6:00 pm.

ROLL CALL:

APPROVAL OF AGENDA: Mr. Kirschman made a motion to approve the agenda. Ms. Lenger seconded. The motion passed unanimously.

PUBLIC COMMENTS: None.

OATHS OF OFFICE: Mr. Lachner was sworn in as Mayor. Mr. Kirschman and Ms. Miller were sworn in as aldermen.

ELECTION OF MAYOR PRO-TEM: Mr. Kirschman nominated Ms. Lenger to serve as mayor pro-tem. Ms. Miller seconded. The motion passed unanimously.

CONTINUANCE OF APPOINTMENTS: Ms. Lenger made a motion to continue the appointments of the City Clerk, City Attorney, Chief of Police, and the banking custodian. Mr. Kirschman seconded. The motion passed unanimously.

APPROVAL OF PREVIOUS MINUTES: Mr. Kirschman made a motion to approve the minutes of the March 20, 2025 meeting. Mr. Weber seconded. The motion passed unanimously.

REPORTS AND COMMENTS:

- Police.
 - Chief Lauer reported on recent traffic stops and several incidents that had recently occurred.
 - The Board discussed mowing issues and other concerns needing abated. Chief Lauer will notify residents.
- Water and Sewer.
 - Maguire Iron is scheduled to perform their warranty work on the standpipe the week of April 21.
 - The Board discussed the need for re-roofing the well houses.
- Attorney. Ms. Force updated the Board on tickets processed and paid.
- Clerk.
 - Ms. Fontana provided the monthly financial report. Ms. Lenger made a motion to accept the report. Mr. Kirschman seconded. The motion passed unanimously.

- The plans for the sidewalk project are under MoDOT review. The City will advertise a distinct agenda item for the May meeting to discuss any questions the public may have.
- The dog clinic will be held on June 7 this year.
- Board Members.
 - Mr. Weber shared that the Dollar General manager thanked the City for the letter regarding the health and safety issue due to the leaky roof in their building.
 - Ms. Lenger reported large dump trucks were utilizing Teel Street and that potholes were forming around town.
